Re: How does a school district access its monthly Medicaid Eligibility Report from iowaidea.org?

### What is the Eligibility Report?

In the web IEP system at iowaidea.org, in the RPTS (AEA/LEA) section is a Medicaid Eligibility report. That report is updated monthly from enrollment data provided by Iowa Medicaid. The iowaidea.org folks will receive the Medicaid Eligibility file on the fifth of the month and will import the data from that file into Iowa IDEA on the sixth of the month at 9 a.m. This will reflect eligibility for that month. Please wait until 10 a.m. or later on the 6th to pull the report. The report was revised in spring 2021. Now the only students on the list are those with current Medicaid and a health service on their IEP. In column P you will find the Medicaid ID number which comes from data submitted by Iowa Medicaid. In column S you will find the date of signature if the parent signed the Parent Consent for your district to release information to Iowa DHS Medicaid. In column T you will find the abbreviated terms for the billable services delivered by AEAs that are in that student's IEP: HS, NR, PP and TR.

### How do I get the Eligibility Report for my District?

The district staff member is to contact the person listed below who is assigned this task at the Area Education Agency that serves their district. These names were confirmed summer 2021. I recommend starting with email and include your own phone number and title. Most AEAs help the LEA learn to access and run their own report. To confirm which AEA serves the district, go to <https://educateiowa.gov/resources/directories>, open the current Iowa Educational Directory, go to the Table of Contents and look for "Public School Districts and Nonpublic Schools by AEA".
