## EXECUTIVE ORDER 86

In September 2015, Governor Branstad signed Executive Order 86 related to bullying. Executive Order 86 provided the following direction:

1. Establishment of the Governor's Office for Bullying Prevention. This office shall address the following:
  - a. Training
  - b. 24-hour hotline
  - c. Reporting procedures
  - d. Cyberbullying
  - e. Data Collection
  - f. Varsity Interscholastic Athletic Participation
2. Bullying and prevention student mentoring pilot program.

The Department of Education partners with the Governor's Office for Bullying Prevention to provide support and collaborate to ensure resources are maximized and used efficiently to meet the direction provided in the Executive Order.

## CURRENT SUPPORTS TO BULLYING PREVENTION PROGRAMMING

In the past two years, the Department of Education has engaged in the following related activities:

- Supported bullying-related calls (eight consultants).
- Annually collected bullying incident report data from all districts in the state, which can be found [here](#).
- Met with the Director of the Governor's Office for Bullying Prevention, established through Executive Order 86 in 2015.
- Developed and provided online resources on the Department of Education website, which are available [here](#) and [here](#). Common definitions of bullying and links to resources for families and schools reside on this website. Resources include suggested steps families, students and schools can take when bullying behavior is suspected, and links to websites and templates that can assist in this process.
- Worked with schools on a variety of topics related to mental health, including bullying, through a five-year Now Is the Time Project Advancing Wellness and Resilience in Education (AWARE) federal grant through the U.S. Department of Health and Human Services, Substance Abuse and Mental Health Administration (SAMHSA).
- Started development of a web-based bullying intake and investigation training that will be shared through AEA PD Online to become available Winter 2018 using funds from the Department's Project AWARE grant (\$14,130).
