Tuition Assistance for Individuals Serving Individuals with Disabilities

Fiscal Year 2011

January 2011

In 2008, the legislature passed Senate File 2425 that implemented the Tuition Assistance for Individuals Serving Individuals with Disabilities Pilot Program. The Iowa Departments of Education and Human Services collaborated on developing a system for participating employers and students to provide tuition assistance to employees of health care facilities serving individuals with mental illness or mental retardation. The participating employers were required to match the state funding appropriated for the program on a dollar-for-dollar basis for the participating employee's tuition.

The tuition assistance program provides tuition assistance for individuals who are employees of health care facilities providing services to individuals with mental retardation and mental illness. Through the program, employees of participating agencies may receive tuition-free coursework at a participating community college. Students who participate in this program are required to maintain employment of at least 20 hours per week while taking the college courses. Participating agencies match state funds allocated to community colleges on a dollar-for-dollar basis. Half of the tuition of each student/employee is covered by the employer, half by state funding allocated to a community college. Participating employers may not charge employees for any portion of students' tuition costs. Through the program, participating students may receive tuition assistance for up to six credits per semester. Students may register for any credit courses within a course of study leading to a degree applicable to the health care workforce and employment by health care facilities providing services to adults with mental illness or mental retardation. The student may enroll at any Iowa community college partnering with the students' employer. The students' coursework may include any college course within a curriculum leading to an Associate of Applied Science, Associate of Science, or Associate of Arts degree.

In FY11 (this includes the fall 2010, spring 2011, and summer 2011 semesters), the Iowa Department of Education reimbursed six community colleges a total of \$11,950.13 under this program. Twenty-five (25) students participated in the program taking 61 courses.

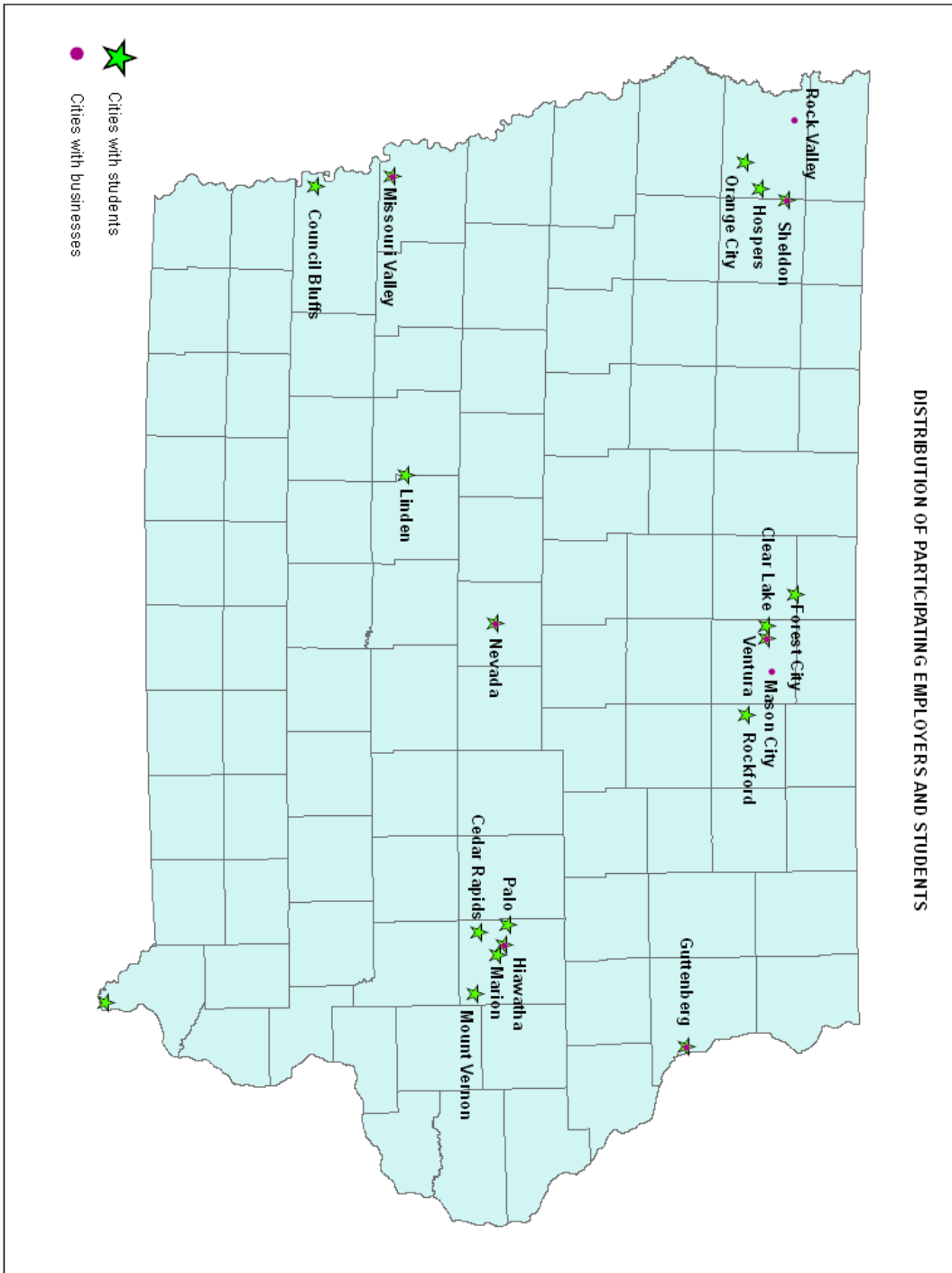
